- 5. This supplemental form of proxy must be signed by you or your attorney duly authorised in writing. If the supplemental form of proxy is signed by your attorney duly authorised in writing, the relevant power of attorney and other relevant documents of authorisation (if any) must be notarised. If a corporate Shareholder appoints a person other than its legal representative to attend the Annual General Meeting on its behalf, the relevant form of proxy must be affixed with the company seal/chop of the corporate Shareholder or duly signed by its director or any other person duly authorised by that corporate Shareholder as required by the Articles of Association of the Company.
- 6. In order to be valid:
  - (i) with respect to H Shares, this completed and signed supplemental proxy form and the relevant notarised power of attorney (if any) and other relevant documents of authorisation (if any), shall be delivered by personal delivery or by post to the Company's H-Shares Registrar and Transfer Office such that the same shall be received by the Company's H-Shares Registrar and Transfer Office not less than 24 hours before the time appointed for the Annual General Meeting. If you have validly appointed a proxy to attend and act for you at the Annual General Meeting but do not duly complete and deliver this supplemental form of proxy, your proxy will be entitled to vote at his or her discretion on the ordinary resolutions set out in this supplemental notice of the Annual General Meeting. If you do not duly complete and deliver the original form of proxy for the Annual General Meeting but have duly completed and delivered the supplemental form of proxy and validly appointed a proxy to attend and act for you at the Annual General Meeting, your proxy will be entitled to vote at his or her discretion on all the resolutions set out in the notice of the Annual General Meeting dated 30 April 2024.
- 10. If the proxy being appointed to attend the Annual General Meeting under this supplemental form of proxy is different from the proxy appointed under the original form of proxy and both proxies attended the Annual General Meeting, the proxy validly appointed under the original form of proxy shall be designated to vote at the Annual General Meeting.
